3. the metrological traceability of the instruments used for the tests
4. send related test certificates

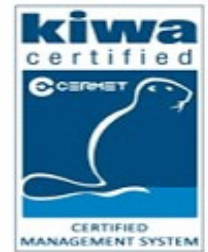
